General Overview

- Accession of Georgia to the Convention of 5 October 1961 Abolishing the Requirement of Legalisation for Foreign Public Documents - 21 August, 2006
- Entry into force of the Convention 14.05.2007
- Convention does not apply to the documents issued by the *de facto* illegitimate authorities and officials of the regions of Georgia: Autonomous Republic of Abkhazia and the former Autonomous District of South Ossetia.
- Two Contracting States raised an objection to the accession of Georgia to the Convention, namely Germany and Greece and the Convention did not enter into force between Georgia and these two States.
- By Note of 2 February 2010 the Embassy of Germany informed the depositary that the Federal Republic of Germany withdraws the objection to the accession of Georgia to the Convention. Therefore, the Convention has entered into force between the Federal Republic of Germany and Georgia on 3 February 2010.
- Georgian legislation: Decree of the President of Georgia #404 of 14 July 2009 on the Approval of the Regulations of Certification by Apostille of Documents.







Conclusions

- The Procedure of certifying the documents exceeds the scopes of simple visual checking of the document.
- The database of the signatures, seals/stamps is updated permanently.
- The Apostille certificate corresponds to the International Standards.
- Georgia among 16 member states of Apostille Convention operating E-Register.
- E-register provides visual checking of an Apostille and underlying public document.
- Search criteria: unique number generated randomly and date of issue of Apostille - to avoid fishing expedition
- Future plans implementing e-Apostille necessity in the nearest future.
